<b>Ratnagiri Customs Division</b>	Ratnagiri city in Ratnagiri District	Entire Ratnagiri District to the south of Jaigad creek Shastri River and Sangmeshwar Chandoli Road upto the border of Ratnagiri District excluding Sangameshwar and Sangmeshwar Chandoli Road but including Jaigad creek
<b>Sindhudurg Customs Division</b>	Kankavli in Sindhudurg District	Entire district of Sindhudurg including Vijaydurg creek.
