Shri. A.Y. Bhalerao, Radio Operator is hereby promoted to the grade of 'Supervisor' Group 'C' in the Pay Band PB-2 Rs. 9300-34800/- + Grade Pay Rs. 4200 - plus usual allowances as admissible. Shri. A.Y. Bhalerao on promotion is retained in his present place of posting, with immediate effect and until further orders.

2. Shri. A.Y. Bhalerao, should join on promotion on or before 30-06-2015, failing which it will be treated as refusal to accept the promotion. In case if he is not willing to accept the promotion he may send his refusal in writing immediately and will not be offered promotion again for one year from the specified date of refusal. Last date of joining.


3. Shri. A. Y. Bhalerao (SC) has been promoted to the grade of Supervisor on his own merit, and hence will be adjusted against unreserved point in the Reservation Roster.

4. Shri. A. Y. Bhalerao will have to exercise his option for fixation of pay under promotion of Rule FR 22(Draft) within one month of the date of this order. If the officer has already been granted 1st, 2nd, 3rd financial upgradation under MACP Scheme in the same higher grade pay, as granted under MACPS, he will not be eligible for pay fixation benefits on promotion. However, if the MACPS has been granted in lower Grade pay than that of the Grade Pay on promotion, then the officer will be eligible for grant of difference in grade pay and no pay fixation benefits will be available.

5. The seniority of Shri. A.Y. Bhalerao will be fixed as per the Select List drawn by the DPC held on 18-06-2015.

6. Joining report and refusal if any, should be sent to this office by 03-07-2015 and all concerned without fail.
