4. At the outset, the Chairman welcomed all the members present in the meeting. The Chairman enquired about the revenue expected to be realised in the next 4-5 days and requested the members to extend their full co-operation to achieve the revenue target. Although there were no agenda points received from the different stake holders, certain points were raised by some members.

**i) Request to increase the Band width from 1 MPBS to 2 MPBS by ICD Talegaon**

The Chairman informed that the process has already been completed and Directorate of System & Data management has already paid the necessary charges for increasing the Band width to BSNL centrally and the work is expected to commence soon. JC(Tech) who is the System Manager has been asked to co-ordinate with the BSNL, Pune for expediting the action.

**ii)** Shri Vinod Sharma, Vice President, Pune Custom House Agents Association stated that exporters are demanding sanction of drawback claims and requested to dispose the same in April 2014. The Chairman has given assurance that all pending DBK claims shall be immediately taken up for disposal in April 2014 itself.

5. As no further points were forthcoming, the Chairman concluded the meeting with a vote of thanks to the members of the Trade.
