The Chairman welcomed the members present in the meeting. The Three points sponsored by Shri Bhagwan Singh, PCHAA, Pune were discussed in the meeting are as under:

1) Request for EDI Patch for online payment of DBK for all the Air export :

The chairman informed the matter has already been taken up by this office with the Commissioner of Customs, Air Cargo Complex and very shortly Transshipment Module from Air Cargo Complex, Sahar to ICD's/Airport under Pune Customs will start with issuing of Public Notice in this regard.

2) Request for services of ADC(Additional Drug Controller)

The chairman informed that there is no case of imports of drugs in the Commissionerate. However this office shall explore the possibility of coordinating and conducting test verification with the State Government Authorities for issuing NOC for exports/imports.

3) System issue related to Chapter 27 – all bills of entries being subjected to additional duty under Notf. no . 190/78 even though the items do not fall under purview of the same. Bills of entry are being recalled and reassessed. This is a system error.

The Chairman informed that it is a system related error and that the matter is being taken up with Director General Systems, New Delhi for rectification of system generated error.

4) The Chairman concluded the meeting with a vote of thanks to the members of the trade.
