

Terms & Conditions for Action

1. Entrance fee of Rs.100/- per person in Cash and will be refunded on completion of Auction proceedings.
2. 20% of the highest bids in Cash / Rtgs / Demand draft / Pay Order (payable at Pune) favoring Dynamic Logistics Pvt. Ltd., to be paid on the spot as EMD at the fall of Hammer.
3. Buyers will have to make balance payment in full by RTGS / Demand Draft / Pay Order before commencement of delivery. The entire lot should be removed within five (5) working days.
4. Delivery of goods will be strictly effected between office hours only i.e., 10.00 hrs. to 17.00 hrs. on all working days.
5. Purchasers are requested to complete all formalities connected with any Statutory Authority / Customs before goods are delivered to them.
6. All Government Taxes Applicable.
7. The Committee present at the time of Sale may refuse to accept the Bid of any person without giving any reason whatsoever.
8. If the purchaser fails to make balance payment or to take delivery of the goods within time allowed from the date of confirmation of sale, the earnest money deposit (EMD) or any money deposited by them will be forfeited and the cargo will be re-listed for sale.
9. No sale will be invalidated by reason of any defect or faults in any of the lots or on account of any of the lots being incorrectly described and no compensation shall be paid in respect of such faults or errors of description.
