The Meeting started with the discussion on the action taken report in respect of agenda points discussed in the last LRM meeting which are as under:-

Commodities having target placed in system: SIIB officer provided a list of 95 Most Sensitive Commodities (MSC) having target placed in system at National level.

(Point Closed)

Tariff wise facilitation: SIIB officer provided import data statement for the period from April, 2018 to January, 2019 and as per statement 90% Bills of Entry are being facilitated under RMS at Pune Customs Commissionerate.

(Point Closed)

Study of top Import Commodities: The Chairman directed all the DC/AC of ICDs to study top import commodities under their respective ICDs/Port which is not targeted at National Level. The LRM can assess the sensitivity of the commodity and can propose the target at Local Level.

(Action: DC/AC, ICDs/Ports)

LRM Meeting: The Chairman directed that Local Risk Management meeting must be conducted in every month.

(Action: DC, SIIB/SIIB Section)

The Chairman directed all the officers to be more vigilant while performing the assessment and ascertain the local risk factors and bring to the notice of the LRM committee for taking necessary action.
