In view of the reference F.No. 278/54/2015-Legal dated 29.02.2016, issued by the Central Board of Excise and Customs, Department of Revenue, Ministry of finance, this office is seeking applications for empanelment of "Special Public Prosecutor" for handling Department cases pertaining to Indirect Tax matters i.e. Customs matters before lower courts of **Ratnagiri and Sindhudurg District**. It may be noted that a person who has been in practice as an Advocate for not less than Ten years is eligible to apply for the post.
