Sub:- Amendments carried out in the Drawback Schedule, 2008-09 vide notification No. 2/2009-Cus. (N.T.) dated 02.01.2009-- reg

Attention of all Trade & industry and Public is invited to the Notification No. 2/2009-CUSTOMS (N.T.) dated 02.01.2009 wherein All Industry Rates of Duty Drawback and/or value caps on some commodities have been enhanced with retrospective effect from 1st September 2008.

2. The exporters who desire to seek the benefit in accordance with the said Notification are advised to file supplementary claims for claiming differential drawback amount, if any, in accordance with the said Notification and Customs, Central Excise Duties and Service Tax Drawback Rules, 1995. The benefit of the same shall not be given suo-moto through automatic processing in EDI where facility EDI system is available.

3. All the Trade Associations and Chambers of Commerce and Industries are requested to bring the contents of this Public Notice to the notice of their member constituents.
