PUBLIC NOTICE NO. 15 /2009 DATED 18.11.2009

All Trade and Industry, CHAs/CHA Association and the Public are hereby informed that the Indian Customs Electronic Data Interchange (EDI) System (ICES 1.5) to facilitate Customs clearance of goods electronically will be launched shortly at the following locations within the jurisdiction of the Commissionerate of Customs, Pune:-

2. The Directorate General of Systems, New Delhi has intimated that the prerequisite of EDI (ICES 1.5) launch process is registration with the Customs by CHAs and Carrier Agencies e.g. Shipping Lines, MLOs, Shipping Agents, Consol Agents and Transporters to avail EDI facility for Customs clearances. Registration is required to be done at any of the present 19 ICES 1.0 locations as listed in the annexure. Those who have already been registered at any of the existing ICES 1.0 locations need not re-register as their details are already available with the database and will be picked up directly from the database. However, those who are not registered with the existing ICES 1.0 locations need to get themselves registered in any of the listed 19 ICES 1.0 locations as per their choice. Registration with ICES 1.0 is necessary to include details of EDI users in the central directory of the EDI system and so as to allow their documents to be processed by the ICES 1.5 version.
