Subject: Make in India Week being organized from 13-18 February, 2016 –reg.


1 Attention of all the Importers, Exporters, Customs Brokers and the Members of the Trade is invited to the "Make in India Week" (MIIW) being organized by The Department of Industrial Policy & Promotion in Mumbai from 13-18 February 2016. The event is to be inaugurated by the Hon'ble Prime Minister.

2 'Make in India' initiative was launched globally in September 2014 to facilitate investments, foster innovation, enhance skill development, protect intellectual property and build the best in class manufacturing. In order to provide greater momentum to the 'Make in India' initiative, the Government is organizing a landmark event called the 'Make in India Week' in Mumbai from Feb 13 – 18 Feb, 2016. The Make in India Week is intended to showcase the people, policies and partnerships that are driving India's new manufacturing revolution and will provide opportunities to connect and collaborate with India and global Industry leaders/visionaries, academicians, central and state administrators. The theme of the weeklong event would be innovation, design and sustainability planned around the larger canvas of manufacturing.

The role of CBEC is as follows:-

- The CBEC is to disseminate information about the MIIW to various trade bodies that it interact with For a platform of Zonal Advisory Committees (ZAC)/Regional Advisory Committees(RAC)/ and Permanent Trade Facilitation Committee (PTFC), Customs Clearance Committee(CCFC), Open Houses etc are to be used for this purpose.
- The CBEC is to promote MIIW at various platforms/forums of the Ministry, and use its logo on its website, in collaterals/backdrops of upcoming events and all communications till February 2016.

- Upon request from DIPP, the department is to share information regarding recent policy initiatives in respect of matters relating to the indirect taxes measures for facilitating investment, for "Make in India" initiative and ease of doing business.
