
Hon'ble Finance Minister has introduced Finance Bill, 2013 in Lok Sabha on 28-02-2013. Changes in Customs and Central Excise law and rates of duty have been proposed through the Finance Bill, 2013 (clauses 54 to 77 for Customs and clauses 78 to 92 for Central Excise). In order to prescribe effective rates of duty and to carry out changes in the Rules made under the respective Acts, the following notifications have been issued :

Non-Tariff	No.25 / 20 13-Customs(NT)	1 st March, 2013

Unless otherwise stated, all changes in rates of duty take effect from the midnight of 28th February/ 1st " March, 2013. A declaration has been made under the Provisional Collection of Taxes Act, 1931 in respect of clauses 76, 77(b), 91 and 92 of the Finance Bill, 2013, so that changes proposed therein also take effect from the midnight of 28th February / 1st March, 2013. The remaining legislative changes would come into effect only upon the enactment of the Finance Bill, 2013. Retrospective amendments in the provisions of law or notification issued under the respective Acts shall have the force of law only upon the enactment of the Finance Bill, 2013 but with effect from the date indicated in the relevant clause or Schedule. These dates may be carefully noted.

2. Copies of Finance Bill 2013 as well as the relevant Notifications as mentioned above are available on CBEC website - www.cbec.gov.in, as well as on www.indiabudget.nic.in, which may kindly be downloaded from the said websites and may be gone through carefully for further details.

3. All the Permanent Trade Facilitation Member and Customs Cargo Service Providers (CCSPs), Custodians & Trade are requested to bring the same to the notice of all their members/ constituents, for information and further necessary action. In case of any doubt, difficulty, or suggestion relating to interpretation or implementation of the provisions mentioned above, the same may be brought to the notice of the undersigned.
